The Executive Committee members and the Board members recommended that Mr. Bock be appointed to serve on the Bloomington-Normal Airport Authority Board.

Chairman Sorensen presented a request for approval of a State of Illinois Department of Human Services Community Services Agreement for Fiscal Year 2008 for the Court Services Department.

Mr. Renner, Chairman of the Justice Committee, advised that this is a Redeploy Illinois Planning Grant in the amount of \$10,000.00. He stated that this Planning Grant will permit Juvenile Court Services to study whether there are programs, services and

strategies that can be undertaken to reduce the number of juveniles being held in the Juvenile Detention Center and in the State of Illinois Juvenile Corrections facilities. Motion by Renner/Segobiano to Recommend Approval of a State of Illinois Department of Human Services Community Services Agreement for Fiscal Year 2008 for the Court Services Department. Motion carried.
