Re: Equipment Purchase

As detailed in the attached bid summary of our equipment purchases for 2005, the bids and quotes for the equipment budgeted have come in approximately \$73,178.0 less than was budgeted. \$29,015.00 of this was because John Deere and Martin Equipment bid was significantly less than expected due to a new model. International's bid was significantly less this year, as Peterbilt underbid them last year, saving us an additional \$27,299.00 on the tandem trucks.

Because we knew we were tight on funds in the budget process last summer and because of further deterioration I am requesting that we replace the following:
